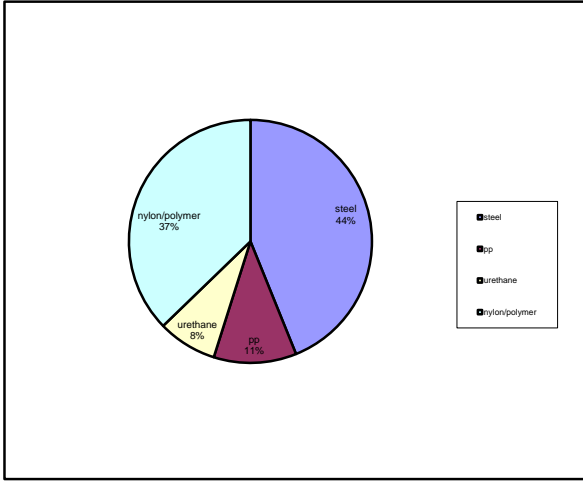

- MR 5: AIS's manufacturing sites are located in Leominster MA. 95% of the materials we purchase, based on our direct material spend, are sourced within a 500 mile radius of our manufacturing operations. 10% are sourced within a 100 mile radius of our operations

- MR 6.1: AIS packaging material is 100 % recyclable and there is an option to have the product blanket-wrapped or shipped without skids.
