Recycled Content - 20% (post-consumer + 1/2 pre-consumer)

1 Point

A02 may contribute to this credit as a typical workstation contains 59.6% recycled content by weight. 55.7% pre-consumer recycled content and 3.8% post consumer recycled content.

- Credit 6** **Rapidly Renewable Materials** - Specify 5% 1 Point
 Bamboo veneers, which are considered to be rapidly renewable, can be specified for worksurfaces.
- Credit 7** **Certified Wood** - Specify 50% of wood products to be FSC-certified 1 Point
 AIS worksurfaces can be specified with FSC certified veneers.
- Note** The inclusion of furniture is optional for LEED NC. If furniture is included in calculations, it must be included in all the calculations for Materials and Resources Credits 3-7.

 AIS Tasklights can contribute to this credit.
- Credit 8.1** **Daylight and Views** - Daylight for 75% of spaces 1 Point
 A02 can contribute to this credit by using low panel heights and transparent materials such as glass and lexan, allowing daylight to reach building occupants.
- Credit 8.2** **Daylight and Views** - Daylight for 90% of spaces 1 Point
 A02 can contribute to this credit by using low panel heights and transparent materials such as glass and lexan, allowing daylight to reach building occupants.
- Note** The inclusion of furniture is optional for LEED-NC.

Innovation and Design Process

- Credit 1.1 - 1.4** **Innovation in Design** 4 Points
 LEED Innovation credits can be achieved for doubling credit requirements or by demonstrating quantitative performance improvements for environmental benefit. Specifying Systems furniture and seating that meets the requirement of LEED-CI EQ 4.5 Low-Emitting Materials, Systems Furniture and Seating, may earn an innovation credit.
- A02 meets the requirements of both Option A (GREENGUARD Certified) and Option C (BIFMA X7.1 -2005). Product restrictions: no fabric covered flipper doors. GREENGUARD certificates can be obtained from www.greenguard.org
